

## **Epic Minnesota Final Four VIP Experience Sweepstakes**

### OFFICIAL RULES

**No Purchase Necessary TO ENTER OR WIN. A Purchase will NOT INCREASE YOUR Chances of Winning.**

**ELIGIBILITY:** Open only to legal residents of the fifty (50) United States and the District of Columbia, 18 years of age or older. Void where prohibited. Employees (and their immediate families (parent, child, spouse or sibling and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related) of the National Collegiate Athletic Association (“NCAA” or “Sponsor”) and its respective parent, affiliates, subsidiaries and advertising and promotion agencies are not eligible to enter or win. Limit one (1) entry per person, using one only (1) email address for the duration of the Entry Period. You may only use one (1) email address to enter. Multiple entries received from any person or e-mail address after the first entry received from that person or email address will be void. Entries generated by script, macro or other automated means or means which subvert the entry process will be void. All entries become the property of Sponsor and will not be acknowledged or returned.

**RANDOM Drawing:** One (1) potential winner will be selected in a random drawing held on or about March 21, 2019 from all eligible entries received by an independent judging agency. Odds of winning depend on the number of eligible entries received throughout the Entry Period.
